ZONING BOARD OF APPEALS REQUIREMENTS FOR APPLICATION

Please bring the following papers and information when you submit your application for the Zoning Board of Appeals:

1. Application – completed, signed and notarized.
2. Full Disclosures Affidavit – completed , signed and notarized.
3. Eight (8) copies of the property survey – showing all structures existing on the property. Survey must show dimensions of ALL existing and proposed structures.

NOTE: All items described in paragraph 3, must be clearly shown on the survey. The exterior dimensions of each item, the distances from front, rear and side property lines shall be accurately shown on the survey. There will be no exceptions to this requirement. Failure to provide this information may result in the dismissal of your application or may require a completely new survey.

4. Copy of the original Denial Letter received from the Building Department.
5. The Board requests Photos of the property to see the layout of the land and property lines. **At least Eight (8) Photos must be submitted with all commercial properties.**
6. **All applications must submit photos of the legal notice signs posted before hearing.**
7. Please note that all Commercial Applications are required to send certified Notice of Public Hearing Letters to properties within a 250' radius of premises.
8. **Filing Fees:**
 - a. Commercial, Business, Multiple Dwelling and Industrial \$500.00
 - b. Construction of a new one family dwelling \$200.00
 - c. All other applications \$100.00
9. Signs must be posted 10 days prior to the public hearing. Signs can be purchased at the Village Hall for **\$20.00.**
10. A Sign Posting Affidavit needs to be signed, notarized and brought to the hearing.
11. An inspection of the property will be conducted by the Board members on the Saturday before scheduled hearing date.
12. Anyone appearing as agent for application at the time of hearing must provide a completed owners endorsement.

**ZONING BOARD OF APPEALS
SIGN POSTING INSTRUCTIONS**

All notice signs as required by Village Code for public hearing shall be posted as follows:

1. For a minimum of ten (10) days prior to the date of the scheduled public hearing.
2. On the property which is the subject of the public hearing.
3. Not more than fifteen (15) feet from street/curb line.
4. The view of such sign from the street shall be unobstructed.
5. Not less than three (3) feet, measuring from the bottom of the sign, from the ground.
6. Supported by adequate means to prevent falling or blowing away due to inclement weather.
7. Protected to insure legibility of notice information.
8. Pictures of posted sign must be submitted with signed sign posting affidavit.
